Special Awards – Sunday only

After the BOV, BOW, BOS, Select Dog and Select Bitch competition is completed, the Judge may give Awards of Merit to the remaining dogs & bitches (up to 10%) that completed the BOV competition.

AKC National Owner-Handled Series (Thursday and Sunday)

Judging for the AKC National Owner Handled Series is conducted following Best of Variety judging. All eligible dogs in the BOV competition (including WD & WB) will stay in the ring after the judge makes their placements in BOV competition. Dogs must be handled by an eligible owner/handler for the AKC NOHS throughout the breed level (all classes, Winners, and Best of Breed) competition.

Non-Regular Classes Involving Multiple Dog Entries (Sunday only)

STUD DOG CLASS – Is for stud dogs and a minimum of 2, or maximum of 3 of their get. The stud dog MUST be entered in the class and shown in the ring with the get. The owner of the stud dog need not be the owner of the get. The get MUST be entered in a regular class, Best of Variety competition or some other non-regular class. The class will be judged on the merits of the get.

BROOD BITCH CLASS - Is the same as for the stud dog class, except substitute “brood bitch” for “stud dog” and “produce” for “get”.

BRACE CLASS - Is two dogs, which have at least one common owner and are of the same variety (colored or white). Requires a fee of \$15.00 for the unit. The dogs comprising a brace class must be named at the time of entry. If a dog, which is part of a brace class, is not entered in another class, it MUST be entered for “Brace Class Only”. In making for “Brace Class Only”, full particulars must be given for each dog on individual entry forms. An entry form for a dog entered in another class and entered as part of a brace MUST be marked accordingly in the space provided for Additional Classes - “Brace Class”.

NOTE: If more than one brace is entered by identical ownership, the dogs comprising EACH brace must be designated “brace No. 1”, “brace No. 2”, etc. Contact Show Secretary by email to enter second brace dog in www.foytrentdogshows.com. Both animals must be intact.

Breeders Cup Competition - Special Attraction (Sunday Only)

ELIGIBILITY: A multiple entry class consisting of 3-5 dogs of the same breed. All dogs must have at least one breeder in common who must be present to accept the award. The individual dogs comprising the entry must be from at least two different combinations of parents but need not be owned or handled by the breeder. Each individual dog must be handled by its own handler. Each dog must be entered individually in a regular class. The entry fee for the Breeders class will be \$5.00 and submitted by the breeder who is entering the class. One entry fee for each breeder. A dog may not be entered for two different breeder entries. The entry form is available in this document. If entering Breeders Cup Competition online, the Breeder should enter and pay for one animal and forward the attached form to Show Secretary at eebeybtca@gmail.com by the entry close date.

JUNIOR SHOWMANSHIP COMPETITION (Sunday only)

**Novice Junior • Novice Intermediate • Novice Senior
Open Junior • Open Intermediate • Open Senior • Master**

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

NOVICE AND OPEN CLASS DIVIDED: Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as AKC Canine Partners Listed Dog "All American Dog/Mixed Breed." Variety, Breeder, Sire, Dam information shall remain blank for mixed breed entrants.
